The Clinical Indemnity Scheme protects you for HSE claims only

The Clinical Indemnity Scheme (CIS) covers you for clinical negligence claims arising from work in public hospitals and HSE facilities.

But hospital doctors face many other challenges besides these claims. Complaints to the Medical Council, Garda inquiries, and disciplinary hearings are not covered by the CIS, which means you could be left facing challenges like this alone.

We protect you for everything else

Most of the cases we handle involve supporting members through medicolegal and ethical challenges, which can have serious reputational consequences.

- In 2024 there were 20,962 clinically active doctors on the Medical Register, up 4.1% compared to 2023.
- According to the Irish Medical Council, 353 complaints involving 391 doctors were received in 2023.
- The cost of defending a typical three-day Fitness to Practise inquiry can easily exceed €100,000.

The CIS is there to make sure patients who experience harm through substandard care are compensated.

**The Clinical Indemnity Scheme covers personal injury claims against staff employed by agencies, covered by the Scheme, who provide care or treatment in emergencies within the island of Ireland. Good Samaritans Acts outside the island or Ireland are not covered.
